OVERVIEW

Migrating for decent work and increased income is an important strategy to support livelihoods and reduce poverty for many individuals and families across South-East Asia. Thailand is a key country of destination for an estimated 3.9 million migrant workers from Cambodia, Lao People's Democratic Republic, Myanmar (CLM), and Viet Nam. Well managed migration benefits individuals, families, businesses and economies as a whole, but gaps in policies and practices mean it can also exacerbate pre-existing inequalities resulting from unethical recruitment, exploitation, abuse, and debt. Women migrant workers face additional challenges in accessing safe and regular migration pathways, receive lower wages, and are often excluded from social protection schemes.

With the outbreak of the COVID-19 pandemic, the vulnerability of migrant workers to economic shock and social exclusion has been significantly exacerbated. As of July 2020, IOM estimated 310,000 migrant workers from CLM had returned to their countries of origin, the vast majority from Thailand, facing lost livelihoods and insufficient income. Migrant workers are essential to economic resilience and recovery across the region, and can act as key drivers for building back better if provided with tailored support and opportunities.

The **Poverty Reduction through Safe Migration, Skills Development and Enhanced Job Placement in Cambodia, Lao People's Democratic Republic, Myanmar and Thailand (PROMISE) Programme**, is led by the International Organization for Migration (IOM) in partnership with UN Women, and funded by the Swiss Agency for Development and Cooperation. PROMISE aims to improve employment opportunities and conditions for women and men migrants in Thailand from Cambodia, Lao People's Democratic Republic and Myanmar through enhanced skills and protection, leading to poverty reduction. It achieves this through the following three outcome areas:

RESPONSIVE:



Migrant workers, especially women, are able to utilize decent employment and safe migration schemes through enhanced collaboration between potential employers, relevant sector associations and skills development partner.

INCLUSIVE:



Migrant workers, especially women, enjoy greater access to skills development in target sectors, leading to improved employability abroad and at home.

PROTECTIVE:



Migrant workers, especially women, receive greater protection through strengthened policy frameworks, enhanced assistance services and safe migration information at all stages of the migration cycle.



SUPPORTED COVID-19 RESPONSE




